From Pastor Anne Wickland

We're halfway through Lent and Holy Week is on the horizon! Thank you to all of those who have provided food (or signed up for future weeks!) for our soup suppers, and to those who have helped lead our Holden Evening Prayer! I've enjoyed our time together in community and worship.

Our first soup supper, I was unsure if I would be able to make it in time—I was juror number 4 in a trial that Wednesday. Monday, I spent the majority of the day at the Dane County Courthouse for *jury duty*, the thing that most citizens groan at. I first thought that because I waited all morning and was the last group called up, that I would be asked to go home, that all the spots were filled! Oh, no. There was one more trial needing a jury for the week – I was then in "the box" being asked questions by the lawyers, thinking that surely the lawyers wouldn't want *me* on the jury! Oh, no. I then had to report for court on Wednesday morning – we were told that it should only last a day, but depending on our deliberation, it might go into the evening. And, not only was I picked to be on a jury, I ended up being the foreperson who led the deliberation, talking through the three counts, organizing the vote, and signing my name confirming what we decided on. Something that I dreaded doing earlier that week, I embraced.

Lent is a time where we self-reflect, repent, pray, fast, sacrificially give and do works of love. While I don't think of me doing jury duty as me sacrificially giving my time, it did make me pause and think of how most of us did not want to be in that room, but we knew that it was something that needed to be done. We were serious about the power given to us, and thought hard about our judgement. It was a space of reflection, of difficult choices, and showing love for our neighbors by making sure justice was served.

It seems a little silly to think of jury duty as a Lenten practice, but the journey made me pause and reflect on how we as citizens were asked to be there for our neighbor in a way that no one really wants to do, but understand how important it is. Lent is our journey towards Jesus' death and resurrection, where we know that Jesus *will* be crucified by the Roman Empire, something we certainly don't want to happen, but we also know that three days later he will rise from the dead. And there is that Easter hope and joy just around the corner that is so important.

We have a few more weeks of our soup suppers and Wednesday worship, and then there's Holy Week. Maundy Thursday (April 17) and Good Friday (April 18) services are both at 7pm. Easter Sunday (April 20), we will have an Easter breakfast 7:30am-8:45am with Easter service at 9am. I look forward to worshiping with you all the rest of our Lenten season and Holy Week.

FROM THE PRESIDENT

The Property Committee is busy obtaining additional quotes for the boiler replacement we hope to have completed this summer. Once we have at least three quotes, the council will review them and make a recommendation to the congregation for final approval at a congregational meeting.

I am anticipating needing to have a day of cleaning at the parsonage to get it ready for our next pastor. I am thinking we will do it on a Saturday morning or Sunday afternoon later in the month or very early May. The more help we have, the faster we will get it done. Please keep an eye out for the date to complete this.

Ben Brusveen, Austin Dahnke, and myself met with Owen Landsverk and Phyllis Baumgartner from Bonnett Prairie in March to discuss where each church is at in the call process. We shared with them that we had interviewed Pastor Anne for a 50% position and reaffirmed our commitment to sharing a pastor with them if the right opportunity were to materialize. If we call Pastor Anne for a 50% position and she decides in the future that she would like to also serve Bonnett Prairie, we would coordinate with Bonnett Prairie to make the shared call work.

We met with Owen and Phyllis at Redeemer. They arrived before we did and did not know how to park in our parking lot. This affirms our need to get the parking lot updates completed. The updates will be done this summer. The earliest this could happen is June due to the need for the weather to be warm enough for the tar. I look forward to the parking lot being updated and presenting a much more welcoming experience for potential new members and visitors.

Do you have a musical talent you would like to share? We would love to have some special music on Sunday mornings. Please contact the office. Due to our music director recovering from a broken arm, the senior choir and bell choir are on hiatus.
