NOTICE REGARDING CHANGES TO COMMUNION

Recently a member of our congregation brought forward two suggestions regarding how we do communion at Redeemer. The first suggestion has already been implemented and seems to be working well: that being that we do NOT put in the center part of the rail for communion.

The reasoning behind this is that

- it causes a certain amount of disruption in the service
- we are a small group of people and can wait to kneel at the rail if that is our choice
- more and more of us prefer to stand anyway, so the center of the "table" works for those folks.

The other suggestion, or I should probably say question is, "Do we really need communion every Sunday?" Most of us remember when we only had communion once a month.

When the question was taken to Council, they deferred the decision to the Worship Team. The Worship Team has decided to offer communion on the FIRST and THIRD Sunday of the month, beginning in March. We will do this on a trial basis. So, we will have communion on March 2, March 5 (Ash Wednesday), and March 16. In April we will commune on April 6 and April 20, which is Easter. Kristi will post the schedule in the bulletin to help everyone remember.

Positives with this change are a reduced workload for the Altar Guild workers and less waste of the communion elements, communion cups, etc. More important though is the idea that perhaps we will think about what communion means if we do it less often and it is not just rote behavior.

We appreciate people coming forward with suggestions from their perspective. We are all in this together.
